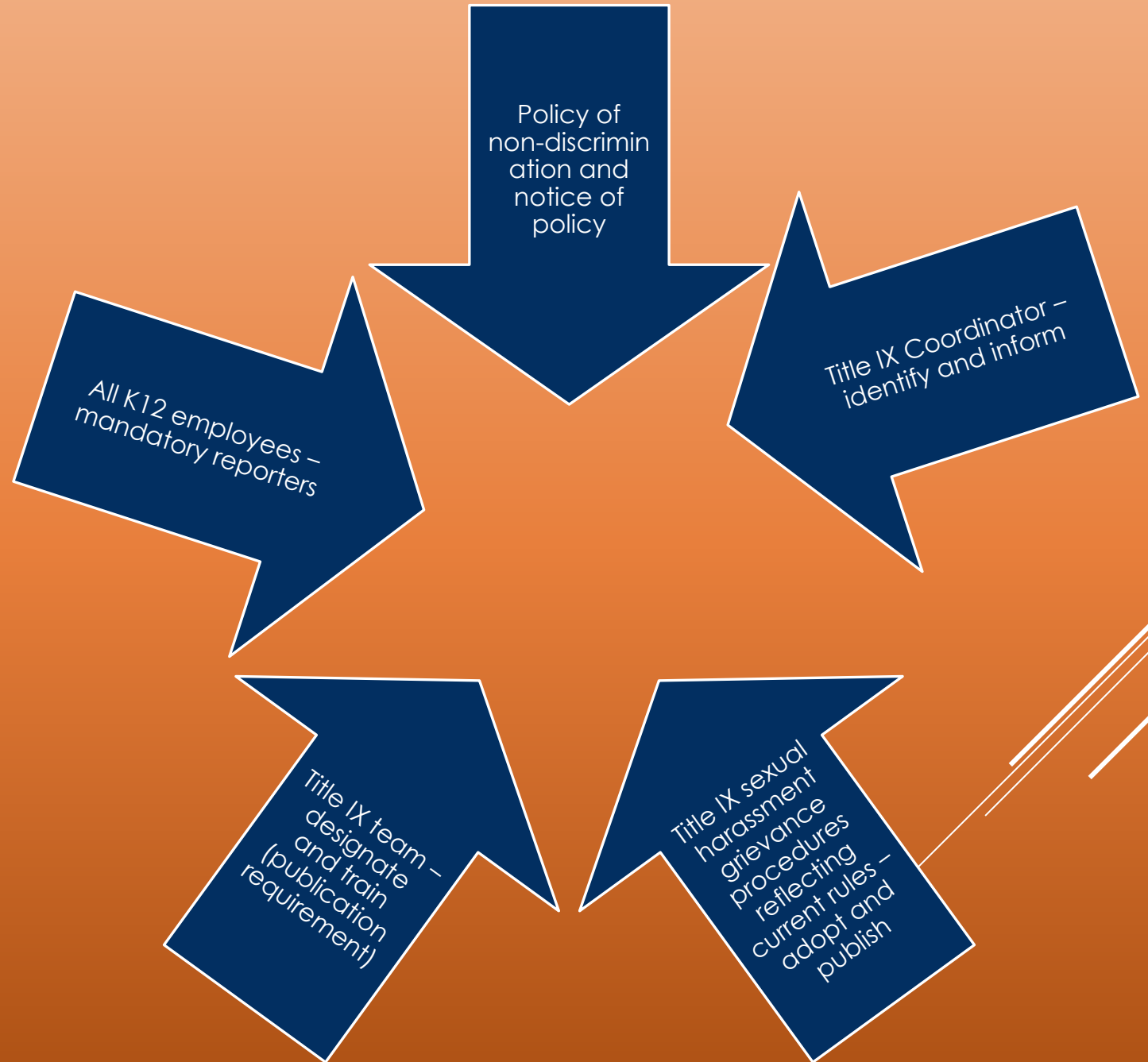


TITLE IX RULES (WHICH SCHOOLS IN IDAHO ARE SUBJECT TO) – THE “2020” RULES

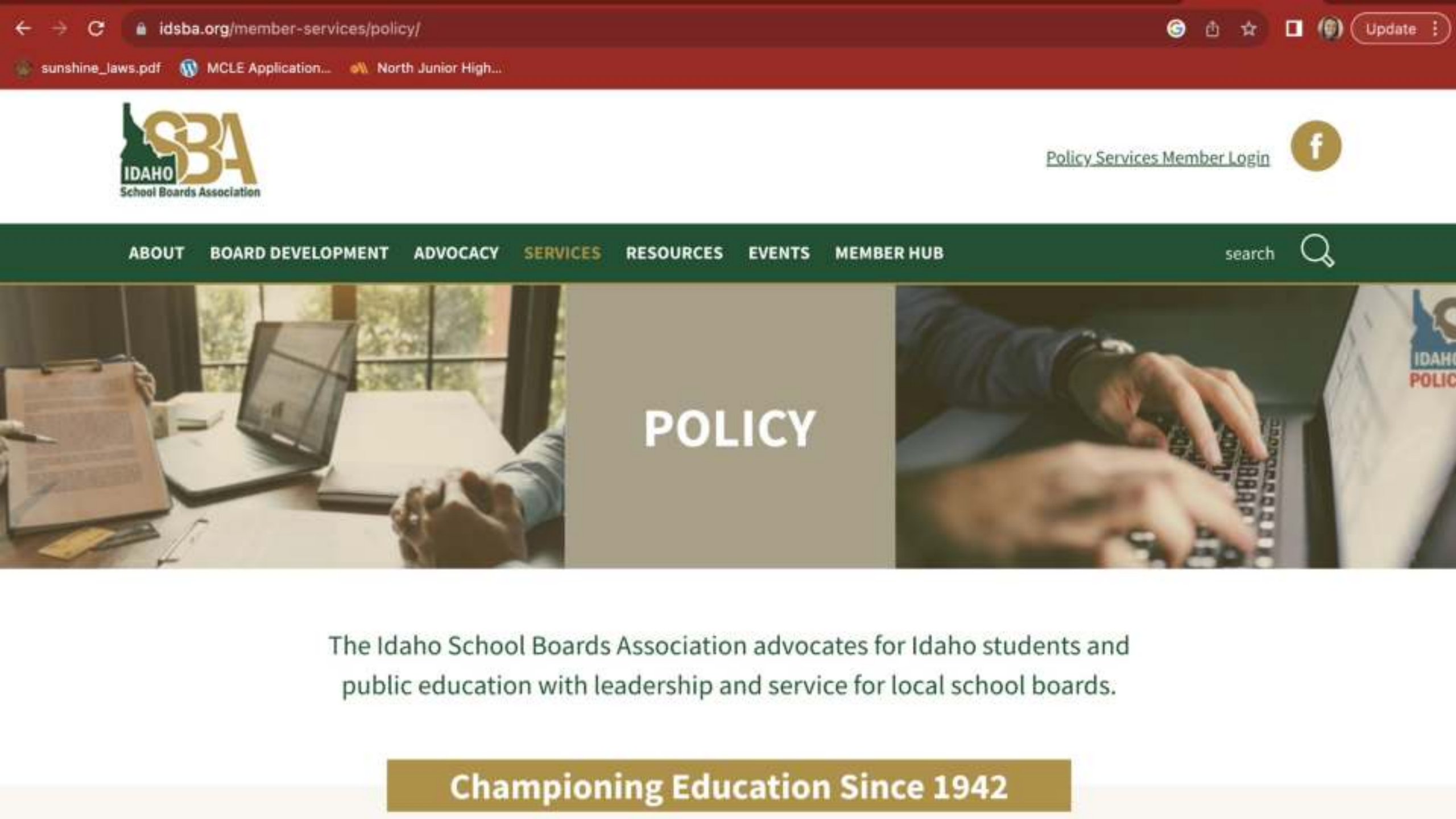
